Juror

Birmingham artist **Amy Pleasant** holds an MFA from the Tyler School of Art. She is represented by the Jeff Bailey Gallery in New York, and recently finished a public installation at the Birmingham Museum of Art.

Awards

\$600 in various merit awards, with specific amounts and categories to be determined at the time of judging.

Eligibility

The exhibition is open to current Sumter County residents and UWA students who are 18 years of age or older. Each artist may submit up to 3 entries. The categories include painting, photography, drawing, printmaking, fabrics, mixed media, ceramics, sculpture, and stained glass. Only original designs and constructions are acceptable. No kits or commercial porcelain molds may be used. All work must have been created after March 1, 2008. The exhibition committee reserves the right to reject any entry. The judge and the committee will determine selection and placement of pieces to be exhibited. Entries must be suitably mounted or framed for museum display and must include hardware necessary for hanging.

Delivery

Entries should be delivered to the Coleman Center, 630 Ave A, York on **Friday, March 12th 10 AM - 12 PM and 1 PM to 4 PM**, or **Saturday, March 13th 9 AM - 12 PM**

Return of Entries

All entries must be picked up by the artist or a representative on **Friday, April 30, from 10 AM to 12 PM and 1 PM to 4 PM.**

Friday, March 12th, 10 AM - 12 PM and 1 PM to 4 PM - Entry drop off

Saturday, March 13th, 9 AM - 12 PM - Entry drop off
Friday, March 19th, 6 - 8 PM - Opening Reception and Awards Ceremony

Friday, April 30th, 10 AM - 12 PM and 1 PM to 4 PM - Pick up work
